1. Mr. Pacheco called the meeting to order at 3:12p.m. A **Quorum was present**. Introductions were made.

2. **October 23, 2025 MINUTES** were reviewed, and no comments or changes were requested. Minutes were adopted for October 23, 2025. (Ms. Falomir, seconded Mr. Cole) **Motion Carried.**
3. **CALRECYCLE LAMD**

4. **IC INTEGRATED WM PLAN/BUDGET**

Ms. Galarza provided the following updates.

 - IVRMA is leading the ICIWMP update as a regional coordination effort providing centralized project management, cost efficiencies, and reduced administrative duplication. It was noted that without IVRMA coordination responsibility would revert to Imperial County potentially resulting in delays and increased complexity.

- Jurisdictions received review materials on October 27, 2025, including a PowerPoint presentation, proposal summary, and Phase 1 work framework. The current request applies only to Phase 1, with Phase 2 to be presented as a separate action at a later date.
- IVRMA requested TAC approval to recommend the Phase 1 consultant award forward the item to the Management Committee and Board for final approval, and approve a related budget amendment. Timely approval was emphasized as essential to maintaining compliance and avoiding funding or implementation delays.
- Phase 1 was approved consultant award for the ICIWMP update and forward the item to the Management Committee and IVRMA Board for final approval. (Mr. Pacheco, seconded Mr. Cole) **Motion Carried.**

5. IVRMA UPDATES

Ms. Gonzalez provided the following updates.

- IVRMA expressed interest in expanding engagement with local schools through additional presentations. A meeting was held with the Outreach Coordinator from the Brawley Elementary School District. This meeting is expected to serve as the foundation for future integration of IVRMA programming within schools.
- IVRMA is updating brochures and the website to include HHW facility opening dates. Upon completion, materials will be ordered and distributed to each city
- Community Outreach (November): IVRMA organized four community events. SB 1383 Seminar held at Palmeras Apartments in Imperial with strong resident attendance and engagement. Partnership events participated in a health fair in Westmorland in collaboration with First 5 Imperial and National Night Out in Calexico. IVRMA also participated in the Tree Lighting for City of Calexico.
