4. EDIBLE FOOD CAPACITY PROJECT/RECOM.

- ReCREATE has provided a final update on the Edible Food Recovery Capacity Program. (See attachment Report for reference)

Ms. Galarza provided the following updates.

- Ms. Less has provided the Final report for the Edible Food Recovery Capacity Program to her and will be transferring the report to USBs and will be dropping off one to each jurisdiction for each to have a copy of the final report.

5. IVRMA UPDATES

Ms. Galarza provided the following updates.

- IVRMA started the collaboration with the paint care program to increase the capacity for paint received in Imperial County for residents and small businesses. The aim is to promote the program through regular operations, the VSQG program, and cleanup events. There was a capacity issue for the paint program at Imperial County and was brought up to IVRMA, and it was announced that IVRMA collect paint from all three facilities, significantly increasing capacity. A curbside program for used oil pickup was also discussed, which will be promoted and implemented in collaboration with Republic Services and CR&R. A grant application for the beverage container program was mentioned, IVRMA is in the process of applying, which would fund the installation of 75 recycling bins in public areas and water refill stations in schools and public facilities. The reimbursement process for the grant was explained, with all costs related to installation, permits, and service hours being eligible.

Ms. Gonzalez provided the following updates.

Ms. Leal provided the following updates.

- In the month of August IVRMA outreach department has been focusing to target more small businesses for the VSQG Program .
